SUBJECT: 2014 City Street Hot-Mix Resurfacing Improvements
Lovers Lane - Road Closure

STEUBENVILLE - The City of Steubenville will begin the 2014 City Street Hot-Mix Resurfacing Improvement / Harvard Avenue Waterline Replacement Project starting Friday, August 15, 2014 at 7:00 A.M.. The initial work will involve the saw cutting of the pavement on Lovers Lane and also on Harvard Avenue where the new waterline will be installed. The work on Lovers Lane is so the contractor can excavate and locate the existing waterline for water connection tie-in.

Beginning on Friday, August 15, 2014 at 8:00 A.M.; Lovers Lane will be CLOSED to through traffic from Fort Steuben Drive (Mall Drive) to Sunset Blvd during the hours of 8:00 a.m. to 6:00 p.m. Local access to properties on Lovers Lane from Harvard Avenue to Fort Steuben Drive will be maintained by means of Fort Steuben Drive. Motorists are advised to use John Scott Hwy and Sinclair Avenue as the detour.

The Project Street; Harvard Avenue, will be posted "NO PARKING" at least one day in advance. If vehicles are left on the street, vehicles will be towed and owners will be responsible for towing and storage fees. We apologize for any inconvenience.
