

## STEUBENVILLE MUNICIPAL COURT

The Minor Misdemeanor Traffic Offenses listed below do not require a Court Appearance if the offender has not had 1 or more violations in the last 12 months.

The offender may pay the amount listed for each offense with the Violations Bureau/Clerk of Courts in person or by mail prior to the Court Appearance Date listed on the ticket. Such payment will be deemed to be a plea of Guilty and Waiver of Trial. Points will be assessed by the BMV where applicable.

The Failure to Appear or make a payment on or before the Court Appearance date may result in your arrest and/or your driver's license being forwarded to the BMV for License Forfeiture.

For traffic violations not listed below, the person cited must appear in Court on the date indicated on the ticket.
