

STEUBENVILLE MUNICIPAL COURT

All persons cited for a Minor Misdemeanor Criminal Charge shall appear in Court at the date and time indicated on the Charging document. They will be released on their own recognizance, to appear at such date and time.

Those cited for other misdemeanor charges, M1 – M4 may be released according to the following bond schedule, which bond shall be forfeited should the person cited fail to appear and an arrest warrant will be issued.

The bonds for the following offenses will be set at arraignment by the Judge; Defendant shall be held in jail pending appearance.

1. All Felonies which have not been predetermined on this schedule
2. Domestic Violence
3. Assault
4. Violation of a Protection Order
5. Menacing by Stalking
6. Aggravated Menacing
7. Any Criminal offense involving a weapon
8. Resisting Arrest
9. Fleeing & Eluding a Police Officer
10. OVI (Second Offense or more)
