

**NOTICE OF PUBLIC HEARING  
PROPOSED COMMUNITY DEVELOPMENT PROGRAM AMENDMENTS**

The Steubenville Planning and Zoning Commission will hold a public hearing on Monday, June 1, 2020 at 7:00 p.m. in the City Council Chambers, Steubenville Municipal Building, 123 South Third Street, Steubenville, Ohio.

The purpose of the public hearing will be to receive citizen comments and recommendations concerning proposed amendments to the City of Steubenville's Consolidated Plan and proposed changes within the F.Y. 2019 Annual Action Plan and Community Development Block Grant Program. The proposed changes are intended to provide for coronavirus response and will be funded with Coronavirus Aid, Relief and Economic Security Act (CARES Act) (Public Law 116-136) supplemental CDBG funds, and will amend the Annual Action Plan and Community Development Block Grant Program as follows:

03C Homeless Facilities (not operating costs): Urban Mission Homeless Shelter Dormitory Roof & Masonry Repairs, located at 142 N Sixth Street	\$95,000.00
18C Microenterprise Assistance: assistance to existing and new businesses with 5 or fewer employees to include technical assistance, training, mentoring, design assistance, and coordination with Continuum of Care (CoC) services.	\$270,667.00
<b>TOTAL FUNDS ALLOCATED</b>	<b>\$365,667.00</b>

Based on the proposed actions referenced above, all of the funds (100%) will comply with CDBG Program National Objectives.

The goals of the Consolidated Plan are to: (1) retain and expand safe and affordable housing for extremely low, very low, low and moderately low income household, (2) establish healthy neighborhoods through balance diverse development of public facilities, infrastructure, housing, commercial, recreational and safety activities, and (3) retain and expand employment and business opportunities for City residents. The above activities are to be funded with CARES Act supplemental CDBG funds. City Council Chambers is wheelchair accessible.
