

**NOTICE OF PUBLIC HEARING  
PROPOSED COMMUNITY DEVELOPMENT PROGRAM AMENDMENTS**

The Steubenville Planning and Zoning Commission will hold a public hearing on Monday, March 1, 2021 at 7:00 p.m. in the City Council Chambers, Steubenville Municipal Building, 123 South Third Street, Steubenville, Ohio.

The purpose of the public hearing will be to receive citizen comments and recommendations concerning proposed amendments to the City of Steubenville's Consolidated Plan and proposed changes within the F.Y. 2014 Action Plan and Community Development Block Grant Program. The proposed changes will amend the Action Plans and Community Development Block Grant Program as follows:

The goals of the Consolidated Plan are to: (1) retain and expand safe and affordable housing for extremely low, very low, low and moderately low income households, (2) establish healthy neighborhoods through balance diverse development of public facilities, infrastructure, housing, commercial, recreational and safety activities, and (3) retain and expand employment and business opportunities for City residents.

Citizens, representatives of community groups and non-profit organizations and public service providers are encouraged to become informed about the consolidated planning process and to express their views and comments regarding the city's needs, program activities to meet these needs and proposed use of funds.
